Elaine Jaffe, Stefania

Pittaluga, and Mark Raffeld. Dr. Barry has a broad research background and is a well-published author with many peer-review publications in areas including hematopathology, immunohistochemistry, and breast cancer. He has authored several book chapters and has delivered numerous lectures on behalf of the United States and Canadian Academy of Pathology, American Society of Clinical Pathology, College of American Pathologist Foundation and been an invited speaker for several State and International Pathology Societies.
